Town Attorney Linda Zuech was contacted by Stephen Ressa to discuss any Harborview agreements and arrangements made with the T.N.H.


Commissioner Giordano spoke with the attorney handling the Keyspan / Verizon lawsuit.


Attorney Stephen Ressa stated that he has had no response from the Town of North Hempstead regarding Harborview garbage pick-up.


Special Note: a third accounting firm (Sheehan & Co.) expressed interest in the position but did not send in a proposal.






